



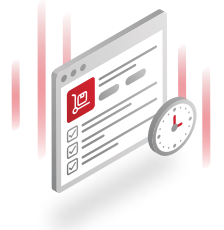

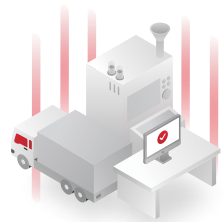

see and control how your organisation commits its financial resources. Procurement is a flexible application designed to manage all formal ontracts/orders, be it purchasing, works or service contracts.

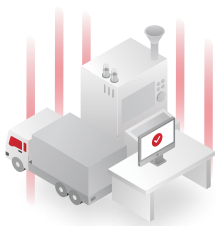
its features include budgetary control, Request for Proposal (RFQ) management, vendor portal, negotiation tool, procurement ordering, arehousing & stock anagement and vendor bill management.

- » budgetary control feature to ensure every desired financial commitment is subjected to an automatic system based check before approval.
- » provision to manage RFQs on listed vendor portals, through which RFQs are initiated and submitted.
- » application handles automatic comparison of rates and quote. Provision to extend and modify with built in controls.
- » provision to combine or split approved indents to provide benefits of consolidated purchase as well as emergency purchase of select items.
- » negotiation tool providing information at unit rates of last purchase, minimum rate quoted by vendors for better negotiating power.
- » generation of purchase or work or service orders with customizable commercial terms. Facility to split order amongst vendor for better vendor management.
- » order tracking and management through online reports.
- » quality control management before goods / service acceptance through pre-defined quality checkers.
- » provision to reject or reduce shortages and damages including gate pass system for return of rejected goods.
- » warehouse management for cknowledging receipts, issues and inventory accounting. Provision for stock audits.
